Every eBay listing is subject to a listing fee and a final value fee. These fees will be taken out of the sale total prior to the commission. All items will be listed on www.eBay.com within 30 days of contract date. All items will be listed up to two times, after which, any unsold items will be donated to charity unless otherwise noted in the notes section of this contract. If an item is not to be donated to charity as noted in the notes section of this contract, arrangements must be made for pick-up within 15 days of auction end. Any items that have been accepted for consignment and are picked up **prior** to auction end will be subject to a \$10.00 per item handling fee.

WisConsign Online, LLC only accepts high quality, new or gently preowned items with a value of \$10.00 or more. WisConsign Online, LLC reserves the right to reject any items brought in that do not meet these requirements. Consignors are responsible to ensure that all items brought in have not been recalled by the Federal Government. The following described items of personal property are hereby consigned by WisConsign Online, LLC. However, this agreement or any other document, shall in no sense be construed as constituting a sale of the described items to WisConsign Online, LLC. The consigned items are noted as follows:

Items are priced at the sole discretion of WisConsign Online, LLC and are priced based on supply and demand, type and condition of item. Sales are recorded two weeks after payment is received from the eBay customer. Checks and sales summary will be mailed to the address listed in this contract the first of every month or the following business day if the first of the month falls on a Saturday or Sunday. A minimum balance of \$15.00 is required for a check to be issued. It is the Consignors responsibility to alert WisConsign Online, LLC of any change in contact information. Checks not cashed within 90 days of issue become void.

Consignor agrees to hold harmless and make no claim against WisConsign Online, LLC for the damage, theft or loss of any items consigned to WisConsign Online, LLC. Consignor holds title and/or claim to consignment items; full cooperation will be given to the local authorities if an item is suspicious. Consignor agrees to hold harmless and indemnify WisConsign Online, LLC for any liability that may arise from consignor's merchandise. Reasonable care will be taken to prevent such losses.
